In 2022, the East Hampton Healthcare Foundation completed its 24th year of working to improve healthcare services in our community. We are proud of our accomplishments over this time which have included building and opening both the East Hampton Healthcare Center at 200 Pantigo Place in 2002, as well as the East Hampton Urgent Care Center at 470 Montauk Highway in 2008. And most excitingly, a ceremonial groundbreaking was held in Spring of 2022 for the latest of our endeavors—the East Hampton Satellite Emergency Department, slated to open in 2024—for which we collaborated with and provided fundraising support to our friends at Stony Brook Southampton Hospital for this much needed healthcare resource for our community.

Satellite Emergency Department Update

With a planned opening set for 2024, construction of Stony Brook Medicine’s new East Hampton Satellite Emergency Department is now underway. Turner Construction is preparing the site for the foundation of the 22,000-square-foot, state-of-the-art facility, conveniently located on a 4.4-acre site adjacent to the East Hampton Healthcare Center on Pantigo Place.

The new East Hampton Satellite Emergency Department will feature:

- dedicated resuscitation room
- cardiac monitoring capability in every exam room
- fast-track treatment rooms for general, pediatric, obstetrics/gynecology, and ophthalmology patients
- two isolation rooms
- dedicated suite for advanced imaging, including CT and MRI
- scheduled appointments for radiology and screening visits
- on-site ambulance for hospital transport
- rooftop solar panels, a rain-catch garden and native plantings to reduce environmental impact

“The East Hampton Satellite Emergency Department will be part of the Stony Brook Medicine healthcare system and provide vital access to emergency and health services to those who visit or reside on the easternmost end of the South Fork,” said Hal Paz, executive vice president of Health Sciences and CEO of Stony Brook University Medicine. “This new facility underscores Stony Brook’s commitment to offer world-class clinical care throughout the East End.”

In support of our mission to improve the quality and availability of healthcare in our Town, the East Hampton Healthcare Foundation has closely collaborated, planned, and fundraised with Southampton Hospital Foundation and the Town of East Hampton to make this vision a reality for the people of our Town.

Jim Forbes, a former East Hampton Healthcare Foundation Trustee and Treasurer, who serves as the Southampton Hospital Association Vice Chair and Chair of the East Hampton Emergency Dept. Campaign Committee, stated in an SHA

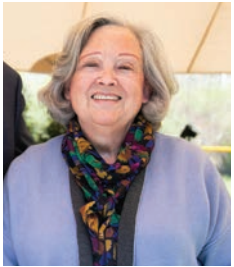

When the Foundation's former Chairman Henry Murray was called to the microphone at the Ceremonial Groundbreaking, it was the perfect opportunity to present a check for over \$1.75 million dollars to Stony Brook Southampton Hospital's Chief Administrative Officer, Bob Chaloner. These funds were raised from generous East Hampton Healthcare Foundation donors along with a grant from the Foundation in support of the Emergency Department and were held for several years, to be given to the Hospital when groundbreaking commenced. Subsequently, the Foundation presented the Hospital with additional donations of \$310,000 collected in 2022. We will continue to accept restricted donations for the Emergency Department from its supporters to help ensure its success in the community.

In spring 2022, the East Hampton Healthcare Foundation hosted a dinner in celebration of the 20-year anniversary of the opening of the East Hampton Healthcare Center and to honor the many years of distinguished service of Chairman Emeritus Henry L. A MILESTONE FOR DR. GAIL SCHONFELD AND EAST END PEDIATRICS

In 2022, pediatrician Gail Schonfeld, MD, celebrated four decades of serving the community at East End Pediatrics, the practice she founded in 1982. As the head of one of the Healthcare Center's first practices since our opening day in 2002, Dr. Schonfeld has been committed to helping the Foundation further its mission, right from the start. In addition to focusing on pediatric and adolescent medicine, her practice provides mental health services for youngsters. When she observed the pressing need for mental health services for under-served youth in our community, she led a collaborative drive to bring those services to her practice with the goal of ensuring that each child's physical and mental health are addressed together through a proactive approach. The Foundation and several of our generous donors have helped to support this important initiative with funding and additional office space in the Center.



DR. GEORGE DEMPSEY'S CONTRIBUTIONS SUPPORT NEW RAPID LYME TEST

East Hampton Family Medicine Director, Dr. George Dempsey works closely with the Foundation to help identify and address issues regarding local healthcare service disparities and inadequacies. With a keen interest in community-based medical research, he has also played an essential role in the breakthrough creation of a new rapid Lyme disease test—pioneered by researchers at Drexel University—by contributing blood samples collected at his practice since 2014 to the Bay Area Lyme Foundation's Lyme Disease Biobank, which honored him for this important work with their Courage Award in 2021.



HEALTHCARE SERVICES FOR UNDERSERVED CHILDREN AND ADULTS

The Foundation underwrites a portion of the cost of primary health services for East Hampton Town residents for those unable to pay. These services are provided by several dedicated physicians at the Healthcare Center and East Hampton Urgent Care. In addition, the Foundation's Emergency Prescription Program provides financial assistance for three months of prescription medications, dispensed at the Healthcare Center's on-site pharmacy, Park Place Chemists, under the direction of pharmacist Conor Cassara.
